The meeting called to order by Chairman Charles Butler 10:14 a.m.

A motion to suspend reading of the May minutes and approved as written was made by Rachel Nix and seconded by Brandon Baker. Unanimously approved.

The financial report was given by Richard Drilling. A motion to accept the report was made by Lindsey Williams, seconded by Brandon Baker. Unanimously approved.

Old Business

The exact smoke detector count was not known. Lindsey said he would get a count on them and send out an email to the members.

Lindsey made a motion seconded by Ronnie to purchase smoke detectors if needed and not exceed 10,000.00 dollars. Motion was approved by members. This decision will be made by Lindsey and Richard Drilling on when detectors will need to be purchased.

Motion by Wrotie seconded by Brandon to approve Snowball Fire Department's request for 50 smoke detectors. Motion approved by members.
