General Information

Arkansas VINE is a free and anonymous *telephone* or *email* service that provides victims of crime two important features: information and notification. Arkansas VINE is provided by the Arkansas Crime Information Center.

Arkansas VINE will monitor the custody status of offenders in county jails, the Department of Correction and Probationers/Parolees as well as court information from the Prosecuting Attorney's Offices. Information is available to callers 24 hours a day, 365 days a year.

Arkansas VINE is available in **English and Spanish**. A **Live Operator** is available to anyone calling the toll-free number for any reason. The operator can connect non-English or non-Spanish speaking callers to interpreters of 195 other languages.

Data Transfer Schedule

County Jail:	Every 15 minutes, 24 hours a day, 7 days a week.
DOC:	Every 30 minutes, 24 hours a day, 7 days a week
Probation/Parole Information:	Every 60 minutes, 24 hours a day, 7 days a week
AOC Court Information:	Three times daily
PA-Court information:	Once per day

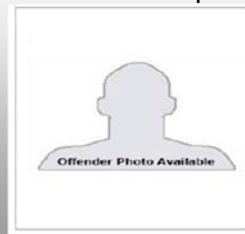

Registration

Crime victims and concerned citizens may register for notification by calling Arkansas VINE's toll-free number or by visiting www.vinelink.com. Crime victims and concerned citizens can register up to **5 phone numbers** and **5 email addresses** each time they log into Arkansas VINE. Hearing impaired victims can also receive notification through TTY (teletypewriter) or email. The following information will need to be provided to Arkansas VINE:

- ✿ A telephone number, including area code, where they can be reached for notification, either by call or text, or both.
- ✿ All registrations require a 4-digit Personal Identification Number (PIN).

Notification Calls

Notification calls to registered persons will be made when one or more of the following occur:

Normal: Calls will be made every 30 minutes for 12 hours or until the call is confirmed. Calls are confirmed and stopped by entering your PIN. Notification messages will be left on an answering machine, but calls will continue every 2 hours for 12 hours.

Non-Emergency: Calls will be made every 30 minutes between 7:00 am – 10:00 pm until the call is confirmed. Calls are confirmed and stopped by entering your PIN. Notification messages will be left on an answering machine, but calls will continue every 2 hours between 7:00 am – 10:00 pm.

Death (24 hour delay)	Non-Emergency Delay
Transfer (2 hour delay)	Non-Emergency Delay
Out to Court (1 hour delay)	Non-Emergency Delay
Transfer to Boot Camp (2 hour delay)	Non-Emergency Delay

Non-Emergency Delay Transfer: Calls will be made every 30 minutes between 7:00 am – 10:00 pm for 24 hours or until the call is confirmed. Calls are confirmed and stopped by entering your PIN. Notification messages will be left on an answering machine, but calls will continue every 2 hours for 24 hours between 7:00 am – 10:00 pm. **Notification calls are delayed for 2 hours after the transfer record is received by Arkansas VINE.**

***Re-Entry-** the re-entry facility will help inmates eligible for re-entry to learn job skills, sign up for health care and meet with their families to re-establish relationships. It is for inmates who are within 18 months of their parole date.

Advanced: Calls will start up to 120 days prior to the expected date of event (see schedule below). Calls will be made every 30 minutes between 7:00 am – 10:00 pm until the call is confirmed. Calls are confirmed and stopped by entering your PIN. Notification messages will be left on an answering machine, but calls will continue every 2 hours between 7:00 am – 10:00 pm.

Victims must also register with the **Arkansas Department of Corrections (ADC) Victim Notification Coordinator** to receive notification on ADC Inmate's request for Furlough, Meritorious Furlough, Work Release and Act 309 transfer. That phone number is **870-267-6677**. Victims have 30 days to protest the ADC Inmate's request for Furlough, Meritorious Furlough, Work Release and Act 309 transfer.

Arkansas VINE will notify registrants on the date the ADC Inmate is to be released for Furlough, Meritorious Furlough, Work Release or **Act 309 transfer**.

Probation/Parole Notifications

- **Change of residence** -- when an offender moves outside the area he currently reports in. This would mean the offender could potentially receive a new officer and/or office for supervision. This notification will use the **normal** calling pattern.
- **Abscond** -- when an offender under supervision stops reporting to his officer and that officer can no longer locate the offender. This notification will use the **normal** calling pattern.
- **Return from Abscond** -- when an offender who had previously stopped reporting to their officer is relocated and will either be sent to prison, the technical violator program, or will just have to begin reporting to their officer again on a regular basis. This notification will use the **normal** calling pattern.
- **Technical violator** -- an in-house 60 day program in Malvern, AR that probationers/parolees could potentially be sent to if they commit a crime. This notification will use the **normal** calling pattern.
- **End of Supervision** -- when an offender on probation/parole no longer has to report to an officer because their time has been served. This notification will use the **normal** calling pattern.
- **Escape** -- when an offender escapes from the in-house technical violator program in Malvern. This notification will use the **normal** calling pattern.
- **Revoked** -- when an offender under supervision commits a new crime or breaks a rule and is held in a local facility or returned to the custody of ADC to serve more of his/her sentence. The offender could remain at the local facility then be released back to supervision. Or he/she can remain at ADC until the end of sentence date but more than likely will be paroled. This notification will use the **normal** calling pattern.

- **Death** -- when an offender dies while under supervision of probation/parole. This notification will use the **non-emergency delayed** calling pattern- utilizing a 24 hour delay before initiating notifications.
- **Interstate compact** -- Arkansas has agreements with other states to exchange offenders between states when necessary. If an offender is paroled to another state for supervision it will be through the interstate compact office. The offender will still have a locally assigned officer that will receive reports on the offender but will be directly supervised by an officer in the state they are paroling to. This notification will use the **non-emergency delayed** calling pattern.

Non-Emergency: Calls will be made every 30 minutes between 7:00 am – 10:00 pm until the call is confirmed. Calls are confirmed and stopped by entering your PIN. Notification messages will be left on an answering machine, but calls will continue every 2 hours between 7:00 am – 10:00 pm, for 24 hours.
