Commission Chairman Christenson congratulated all those who received promotions.

DIVISION REPORTS:

<u>Fiscal Report</u> – Emma French

Ms. French reviewed the reports which had been distributed to the Commission. She stated since we've only been in this fiscal year for one month we don't have much to talk about. She stated they have been busy getting all of the purchase orders set up for the year and the draw down contracts set up. She advised the auditors are still here, and we're working on the CAFR, which is the Comprehensive Annual Financial Report. It puts State Police in with all the other state agencies and comes into one big report for the state as a whole.

Commissioner Allison asked if anything scares her as she has run this budget so many years, if there is anything that stands out and bothers her. Ms. French advised that the price of fuel still bothers her and we always keep an eye on that, and just whether the revenue for the state will come in so that we will get our part.

<u>Administrative Services</u> – Harmony Daniels

Ms. Daniels presented an oral summary of the written report distributed to the Commission. She reported under Human Resources/Personnel transactions; we had six civilian new hires, three civilian volunteer resignations, three retirements, three extra help hires, and one extra help termination. The Commissioned transactions included one reinstatement, ten lateral transfers, thirty promotions including twenty-four Trooper First Class promoted to Corporal, one disciplinary, one termination, and seven military deployments.

Ms. Daniels then reported on the Health Plan claims which were higher this month. Our overall comparison from July 2012 for total medical and fixed costs is higher by \$653,000.

Our total fund balance is also higher by \$430,000. To give you an idea how we look compared to last month, medical claims and prescription drug claims are lower by \$43,000, and the total fund balance is lower by \$9,000.

Commission Chairman Christenson asked who will be handling Troop School this next time around. Colonel Witt advised that Corporal Gunnett ran the last troop school as the lead Drill Instructor and he will probably be the same one leading this year's Troop School. She said she knows we are beginning to take applications. Colonel Witt advised we're in the process of taking new initial contact forms and setting up tests for the physical assessment portion, the very first portion they take. That should happen sometime this month.

NEW BUSINESS:

Colonel Witt advised the Commission that this year they had to rebid the Health Care Provider for our health plan through State Procurement. We are in the process of doing that. He said the process is a little different than what we've done in the past and we know that there are four vendors that have bid our health insurance plan. There is a protest period that the vendors can go through if they don't agree with the process, so once we get through all that process we should know by next commission meeting who our health care provider is going to be in January. The Oversight Committee will make the recommendation to the Commission, and the Commission will have to vote on the recommendation.

Commissioner Chairman Christenson asked if there was any other new business. Colonel Witt advised they needed to go into Executive Session to discuss personnel issues.

The Commission went into Executive Session at 10:32 a.m. and returned to open session at 11:35 a.m.

Colonel Witt advised he had one recommendation to make for promotion today. Colonel Witt recommended the Commission consider Sergeant Mike Hagar for the vacant Lieutenant position in the Director's Office, Executive Protection. Commissioner Allison made the motion that Sergeant Mike Hagar be promoted to Lieutenant, Commissioner Guinn seconded, and the motion passed.

NEXT MEETING:

The next scheduled meeting will be Thursday, September 12, 2013 at 9:00 AM. The James McCoskey Appeal Hearing will begin at 10:00.

With no new business to come before the Commission, Commissioner Shepherd moved the meeting be adjourned. This was seconded by Commissioner Allison and the motion passed. The meeting was adjourned at 11:39 a.m.
