DIVISION REPORTS:

<u>Fiscal Section</u> – Jenna Castleberry

Ms. Castleberry gave an overview of the reports which were distributed to the Commission. She stated we should be at 8% which we are, for year-end expenditures. We are set up and operating for the new Fiscal year and we have prepared and submitted the biennial budget for FY18 and 19.

Administrative Services - Captain Mike Kennedy

Captain Mike Kennedy presented an oral summary of the written report distributed to the Commission. He began by reporting the Human Resources/Personnel transactions for the month; the civilian transactions include six new hires, five promotions, two lateral transfers, five voluntary resignations, two extra help new hires, and two extra help resignations. The commissioned transactions included one reinstatement, three lateral transfers, one voluntary resignation, and one disciplinary. We currently have two department members on military orders.

In regards to ASP Troop School, they are currently in week 14 and are finishing up their last week of accident investigation, they get three weeks total. For the next three weeks they are going to be up and moving out of the classroom with two weeks of traffic stop scenarios, a manhunt class and active shooter training. We currently have 32 recruits remaining.

Regarding the ASP Health Plan, July paid claims were \$852,029 which is an increase of \$5,073 from last month. The fund balance is \$5,400 lower from last month, for a total fund balance of \$7,011,080 dollars. The average discount savings for the month of July was 73%. We will continue to monitor claims, utilization and funding on a monthly basis.

The next scheduled review of the ASP Health Plan is in September. Last month you were updated on the status of the ASP Health Care Consultant Contract. After rebidding the contract, it will be awarded to Regions Insurance. The contract is scheduled for Legislative Review next week and we will need a vote from the Commission to move forward with that. So at this time I would ask the Commission to take that matter up. Commissioner Burns moved to approve the ASP Health Care Consultant Contract awarded to Regions Insurance, Commissioner Benton seconded and the motion passed.

NEW BUSINESS:

Mr. Richard Green stated we are with the Employer Support of the National Guard and Reserve, a Department of Defense Agency and our main goal is to create a culture of support across this nation in support of our National Guard and Reserves. Pretty important since over 50% of the defense of our nation now is in the Guard and Reserves and State Police certainly creates that since you have about 60 members that are in the Guard and Reserve. Who we are representing here today is Corporal Matthew Ritchie, who is deployed with one of our busiest units and he is certainly a patriot of our nation. We thank him for his service along with the other members of the Arkansas State Police who fulfill our nations call, so that we can appreciate and enjoy our freedoms and liberties that they have protected for us. It is tough on people that are in the Guard and Reserves; they have three things going on in their life, families, civilian employment, and military obligations. If something happens, they are going to take care of their families, their civilian employment and sometimes the first thing that goes is they get out of the military. It is with great support from employers like the Arkansas State Police and the people that stand behind the lines and pick up the slack when they are gone, which allows them to continue their military obligations and it is so important. If Corporal Ritchie were to get out of the Guard, it would probably take about \$100,000.00 to replace him and it is so important that we balance that out between family, civilian employment and military obligations and so we appreciate the Arkansas State Police for their support.

Mr. Green read a short statement from Corporal Ritchie. Corporal Ritchie says working for the Arkansas State Police is a blessing beyond words to me and my family. I wholeheartedly love my profession and get to do what I love as well as the opportunity to work with some great people. The support that has been given to me and my family from the Arkansas State Police since the day that I was told of an impending deployment until today and undoubtedly until I return home has been incredible and my family and I are truly humbled. I will never be able to fully express my gratitude to the individuals of the department as a whole; my hope is that this small jester conveys my family's appreciation to each and every one of you from the Arkansas State Police.

Mr. Green stated we consider Corporal Ritchie a true Patriot of our country but the people who have directly supported him before he left and now that he is deployed, we consider you Patriots as well. We would like to call the following people forward to present you our Department of Defense Patriot Award; Colonel Bill Bryant, Lt. Colonel Shawn Garner, Major Mike Foster, Major Forrest Marks, Lieutenant Barry Saffold, Sergeant Jim Moore, and Georgia Whatley.

Jane English, State Chairperson of ESGR presented the Patriot Awards to Colonel Bill Bryant, Lt. Colonel Shawn Garner, Major Mike Foster, Major Forrest Marks, Lieutenant Barry Saffold, and Georgia Whatley and thanked each of them for their support.

Mr. Green stated we have from the Secretary of Defense for Commissioner Guinn, a statement of support for the Commission saying the ASP Commission itself supports the National Guard and Reserve to present for signature and display in the ASP Commission Room.

Mr. Green stated to someone who has helped me over the last few weeks of getting this all arranged, Ms. English has a Statement of Appreciation from ESGR to present to Donna Humphries.

EXECUTIVE SESSION:

Commission Chairman Guinn announced the Commission would go into Executive Session to discuss personnel matters. Commissioner Basore made a motion to go into Executive Session for the purpose of considering employment, appointment, promotion, demotion, disciplining, or resignation of an employee, Commissioner Shepherd seconded and the motion passed. The Commission went into Executive Session at 10:23 a.m.

The open meeting resumed at 11:07 a.m. and Commission Chairman Guinn announced personnel matters were discussed but not action was taken.

NEXT MEETING:

Commission Chairman Guinn stated he would like to have the next months Commission Meeting on September 7. Commissioner Burns moved to schedule the next monthly meeting of the Commission on Wednesday, September 7, 2016 at 10:00 a.m., Commissioner Basore seconded and the motion was approved.

With no more business, Commission Chairman Guinn asked for motion to adjourn. Commissioner Shepherd made a motion to adjourn the meeting, Commissioner Burns seconded and the motion passed. Commission Chairman Guinn adjourned the meeting at 11:09 a.m.
