NEW BUSINESS:

Commission Chairman Shepherd asked Colonel Bryant to go ahead with the business that he has for today. Colonel Bryant stated there is just one item on the agenda that we need to cover, a reinstatement of a former trooper, Dean Pitchford. Dean graduated from Troop School in the Class 2015A; he was assigned to Troop C, in Post number 2, which would be Clay, Greene and Randolph County. He resigned in September 2016 to accept a position with the Department of Veteran Affairs, he left in good standing and on October 19, 2017, I received a memorandum from him requesting reinstatement to the Arkansas State Police as a Trooper. We completed his background and everything was good, everybody that supervised him said that he did an outstanding job, his performance evaluations were above average. What I would recommend to the Commission is that we would reinstate him and give him a conditional letter of employment. He has passed the PT test, the background, but once we give him the letter he still has to clear medical and psychological and if he does, clears all of that we will assign him to Troop A here in Little Rock. We have some shortages in Little Rock and he would be assigned to Troop A.

Commission Chairman Shepherd stated in order to discuss this if we could get a motion on the floor to re-employ. Commissioner Allison moved to approve the Colonel's recommendation to reinstate Dean Pitchford to Troop A and Commissioner Basore seconded. Commission Chairman Shepherd said it has been moved and seconded to reinstate Dean Pitchford to the ranks of the Arkansas State Police. We have a motion and a second on the floor, is there any discussion. Are there any questions?

Commission Chairman Shepherd asked for the role to be called for votes and the commissioners voted as follows:
