Karen Burgess:

We upgraded our configurator to version 7.5 after several months of preparation and testing. I give great kudos to our DPS help desk and field agents and a loud shout-out to Rick (Stallings). We hired Tom Jones on April 12, he really was a champion.

- Configured and Installed 31 messenger workstations, 217 Mobile data terminals.
- Approved 4 DIS circuits and routers to be removed from system
- 16 Agencies are now directly build by DIS instead of ACIC.
- Removed 7 messenger workstations.
- Requested 7 ORI changes from NCIC: 4 where assigned, 1 was reactivated, and 1 retired.
- Processed 1,657 hot files and 407 owner/lien holder requests.
- Completed 57 audit reports.
- Completed 300 offline searches.
- 463 active missing persons in Arkansas.

Jennifer Tomlin:

- Certified 2,530 users during the quarter with CJIS Online Security Training.
- Certified 11,198 vendors across the nation.
- On April 22, 2021 we combined NexTest and CJIS Online.
- Basic training: 1,041 users with a 90.8% pass rate.
- Advanced training: 89 users with a 97.8% pass rate.
- VINE had over 60,502 new registrations.
- Delivered 502,522 VINE Notifications by phone, text and email.
- JusticeXchange had 162,628 law enforcement searches.
- Investigators placed 18,683 watches; this yielded 3,428 hits on those watches.
- 16,128 DL photos viewed.
- AlertXpress utilized 206 times during this quarter.

- Pseudoephedrine purchases 34,727.
- NPLEx blocked 1,697 attempts to buy pseudoephedrine.
- Metal Theft tracking Program reported 104,238 tickets on 237,756 items scrapped and 4,259 of those tickets yielded a hit on a reported stolen item. That's up over 837 tickets.
- Kristian (Lanes) and I have worked over 2,230 training emails.

Ralph Ward:

- Current NIBRS program status; there are 325 agencies cleared to request & report.
- Twenty Eight (28) agencies and vendors are testing their RMS.
- Kyle (Brown) and I are working with agencies and their RMS vendors to test new systems, helping with technical recording issues.
- We will post the 2020 Crime Statistics on the DPS/ACIC website in July (2021).
- Working with AOC and AFIS on additional charge codes for our state.
- Victim Reports Project – We received several requests form victim groups and organizations. These statistics are used to show the need for funding.
 - a. Funding/Cost (\$30,000) Our NIBRS Repository Vendor (Tac10 Global Software) agreed to pay \$15,000 and Debbie Bousquet DFA (Intergovernmental Services) funded the other \$15,000 from the VOCA grant.

 - Deported sex offenders: 208
 - Incapacitated sex offenders: 93

- 13,643 records entered, 26,367 verified, and 35,985 miscellaneous transaction worked.
- Total of 75,995 records entered, quality controlled, verified or processed for accuracy.
- Processed 23 Governor Pardons.
- Worked 180 mental defects and commitments.
- Sealed 1,033 orders.
- Assisted 73 walk-ins with their records.

Heather Bray:

Directors Report:

Brad Cazort:

- We only had one (1) bill in the last legislative session and it was passed early and signed early.
- There are some things from legislature that we have to deal with: several new sex offender laws that were passed, we are working on updating the sex offender registry form. Several new laws were passed creating new fingerprint based background checks for employment purposes, those must be approved by FBI. We have submitted those to the FBI but have not hear back yet. There were new laws on how to seal records, we are working on changing the petition to seal and order to seal to show updates in the laws.
- In our next Board Meeting (September) we're going to talk about our tokens and seeking Board approval to pass the cost of those tokens to law enforcement.
- During the pandemic, we sought permission from the FBI to allow non-criminal justice agencies to submit background checks using purpose code X. This means they are going to get a state name check only even though they are required to get a federal fingerprint based check. FBI approved this for every state and it lasts as long as the state of emergency was in effect. That state of emergency ended May 30, 2021. Under FBI's rules, every agency who submitted

background checks using purpose code X has ninety (90) days to submit those fingerprints. ASP, and ACIC are working on a joint letter to all those agencies advising them they have 90 days to submit prints and fees if they haven't already paid. That compliance and purpose code X will be an issue that ACIC will audit and FBI will audit.

- ACIC Conference is October 6-8, 2021 please come if you can.

Judge Melanie Martin: Was there legislation this session about the printing of B and C misdemeanors, and then a change in A misdemeanors to be "may" print on A's?

Brad Cazort: I don't think it passed. The law was an A misdemeanor had to be printed and it didn't say B and C misdemeanors shouldn't be, it was discretionary.

Col. Bill Bryant: I don't think it passed. It didn't get out of committee.

- Since our last Board Meeting our Chair has been promoted to Lieutenant so I want to say congratulations to Lloyd.

Judge Melanie Martin: A concern we had during the pandemic was the dissemination by email of ACIC information to authorize users. Specifically for us it was when the prosecutors and lawyers were out of court. Traditional the ACIC is printed in the court room so we were kind of shifted into a "are we authorized to email to a user." My understanding was as long as it's encrypted and it is an authorized user, we are good with that? The regulations have the word fax but I didn't see anything about electronic transmissions?

Brad Cazort: When CJIS security requirements were written they were not anticipating a pandemic. The safest way is making sure they're encrypted.
