### NALOXONE AWARDS:

Lieutenant Aaron Easley stated on December 2, 2020 Trooper First Class Marcus Simpson was monitoring local radio transmission while working on Highway 67 near the 84-mile marker. While working, he learned of an unresponsive male at a nearby apartment complex. Trooper First Class Simpson was the first person on scene and, after assessing the situation, determined the male was likely a victim of an opioid overdose. Trooper First Class Simpson was able to administer a dose of Narcan, reversing the effects of the drug. Trooper First Class Simpson's quick actions undoubtedly prevented the death of the male subject.

Colonel Anthony Sanders stated that he was here on behalf Major General Kendall Penn. He is the Deputy Director of Military Support. As one of the family resounding of the Arkansas Army National Quick Reaction Response Force, Lieutenant Brown has ensured the successful partnership with the Army National Guard support operations. His expertise and capabilities have directly affected the safety of the citizens and the communities we serve. The training Lieutenant Brown has been able to provide our soldiers and airmen has directly influenced the success of many missions, including the mission of the summer of 2020. General Penn sends his gratitude on behalf of the soldiers and the airmen of the Arkansas Army National Guard and looks forward to future partnerships with the Arkansas State Police.

Colonel Sanders presented the lucrative Diamond Award that reads the Arkansas National Guard presents the Adjutant General's Diamond Award to Lieutenant Bobby Brown in appreciation for the leadership and dedication to the soldiers and airmen of the Arkansas National Guard. Always Ready, Always There.

### <u>Fiscal Section</u> – Jenna Castleberry

Jenna Castleberry presented an oral summary of the written report distributed to the Commission. Ms. Castleberry stated June was a fast and busy month for us. We wrapped the fiscal year and ended well. Ms. Castleberry stated that we are currently busy planning the biennium budget due next week on Thursday. We are working hard to get that prepared and submitted. We are also in the middle of the new year start-up processes, so we have a lot going on. Our fuel average for FY22 ended at \$3.12 a gallon. We had budgeted \$2.05 a gallon for that year. It was over, but we were able to manage, and we are doing fine. We budgeted \$4.50 a gallon for this coming year.

Commissioner Hinkle asked Colonel Bryant if we have reduced travel any because of the increase in cost of fuel as far as patrol time is concerned? Colonel Bryant stated no sir, we are still operating at full capacity right now. Jenna and John Smith have done an excellent job at looking at our budget and we are able to continue operations remaining to that fact.

## <u>Administrative Services</u> – Major Charles Hubbard

Major Charles Hubbard presented an oral summary of the written report distributed to the Commission. He began by reporting the Human Resources/Personnel transactions for the month. The uniformed noncommissioned transactions include four new hire and three terminations. The commissioned transactions include two promotions, eleven terminations, which he will add that ten of those were retirements, so our agency took a large hit on our commission side on our retirements. We also had three transfers last month. Currently we have two military deployments.

Regarding the ASP Health Plan, June's paid claims were \$1,418,150.00 which was an increase of \$429,014.00 from last month. The fund balance is \$243,217.00 higher than last month for a total fund balance of \$11,761,952.00. For the month of May, we had an average of 67% discount savings.

Major Hubbard stated just a quick update on our recruiting efforts for our next troop school in 2023, I checked the numbers this morning and we had close to 226 applicants in the cue for troop school, which is pretty good. That number is up from about 50 last week, so we are showing some improvement, and we are getting some numbers coming in and looking forward to that school coming up next year.

Colonel Bryant asked Major Hubbard to discuss with the Commissioners about the upcoming recruiting video and what our plans are with that. Major Hubbard stated sure. We have been working on a recruitment video. We are always trying to find new ways to get the public's attention so that we can get those qualified applicants names in the cue. And this time around, we have been pushing out on social media as well as commercial that we have come up with that will be, hopefully in the next few weeks, getting it out on live stream, which is a service that's provided for T.V. that lets us basically live stream networks, rather than just the cable T.V. This is an internet source for us to be able to reach out to the public, but we will also be putting this out on regular network as well in the future.

Commissioner Hinkle stated that it will be interesting to see the results when that video hits, maybe next month you might have some numbers for us to see if there is definite uptick in applications after this video. Major Hubbard stated yes sir, I agree. Commission Chairman Edwards stated that we just saw a preview of that, and I would like to commend you all on the work. It looked really nice.

### **NEW BUSINESS:**

Commission Chairman Edwards asked do we have any new business to discuss. Colonel Bryant stated yes, Mr. Chairman, we have two to discuss in Executive Session, but I have one for an ASP Lieutenant's slot, Highway Patrol, Troop F. I am going to use Director's Discretion and laterally transfer Lieutenant Alex Krneta from Troop E to Troop F. Besides that, we have two, the Lieutenant in Company D and the Major in Regulatory.

#### **EXECUTIVE SESSION:**

Commissioner Reeves made a motion to go into Executive Session to consider promotion to Lieutenant, in the Criminal Investigation Division, Company D and promotion to Major in Regulatory. Commissioner Basore seconded. The Commission went into Executive Session at 10:27 a.m.

Commission Chairman Edwards called the meeting back to order at 11:25 a.m. Commission Chairman Edwards asked Colonel Bryant if we had promotions to address.

Colonel Bryant stated thank you Mr. Chairman, the first promotion will be the ASP Lieutenant in the Criminal Investigation Division, Company D. My recommendation to the commission would be Sergeant Phillip Pierce. Commissioner Basore made a motion that Sergeant Phillip Pierce be promoted to Lieutenant in the Criminal Investigation Division, Company D. Commissioner Reeves seconded, and the motion passed.

Colonel Bryant stated the next position is an ASP Major position in the Regulatory Division. My recommendation to the commission would be Captain Michael Moyer. Commissioner Reeves made a motion that Captain Michael Moyer be promoted to Major in the Regulatory Division. Commissioner Basore seconded, and the motion passed.

Commission Chairman Edwards stated we did the lateral. Colonel Bryant stated yes sir that is already on the record.

Commission Chairman Edwards stated we have scheduled the Aaron Keith Appeal Hearing for August 11. The commission will meet at 10:00 a.m., followed by the appeal hearing at 11:00 a.m. or upon adjournment of the Commission meeting.
