- Configured 229 workstations (39 messenger workstations, 190 Mobile data terminals)
- 13 workstation removals, 4 applications for direct access
- Approved 4 DIS circuits and routers for removal from system.
- Processed 45 ORI requests; 14 were assigned, 3 reactivated, 28 retired.
- Processed 2,045 hot files and 412 owner/lien holder requests in the last 3 months.
- Completed 13 audit and 4 re-audit reports.
- 540 active missing persons in Arkansas.
- 105 unidentified persons

• 222 offline searches that were processed.

### Jennifer Tomlin:

- Certified 1,933 users during the quarter with CJIS Online Security Training with a 99.5% pass rate.
- Certified 11,131 vendors across the nation with a 99.4% pass rate.
- Basic training: 535 users with an 84.9% pass rate.
- 1073 users took the Basic Refresher, with an 88.3% pass rate.
- Advanced training: 19 users with a 100% pass rate.
- 187 advanced users recertified with an 86.6% pass rate.
- Training worked 2,337 training emails.
- VINE had 47,117 new registrations.
- Delivered 406,653 VINE Notifications by phone, text, and email.
- JusticeXchange had 139,908 law enforcement searches.
- Investigators placed 25,123 watches; this yielded 4,177 hits on those watches.
- 7,691 DL photos viewed.
- AlertXpress utilized 169 times during this quarter.
- 38,545 actual JX logins
- Pseudoephedrine purchases 28,997.
- NPLEx blocked 1,670 attempts to buy pseudoephedrine.
- Metal Theft tracking Program reported 57,448 tickets on 130,813 items scrapped and 3,664 of those tickets yielded a hit on a reported stolen item. February numbers: 28,552 tickets; 65,283 scrapped and out of those 1,744 yielded a hit on stolen property.

### Ralph Ward:

- Current NIBRS program status: there are 312 agencies cleared to request & report.
- 15 agencies and vendors are testing to certify their RMS.
- Working with RMS and software vendors with assisting law enforcement agencies with technical reporting issues.
- Letters were sent to chiefs and sheriffs of agencies that are missing NIBRS data from 2022 and currently following up those agencies to determine if they need assistance.
- A letter was also sent to collect all full-time law enforcement sworn officers and civilian employee counts.
- Working with Administrative Office of the Courts and AFIS team on additional charge codes
