Commissioner Hinkle stated Mr. Chairman, I have a question please, might be best to ask the Colonel, has there been a time when we would not approve the pistol and the shotgun? Colonel Hagar stated not that I am aware of, no sir. Commissioner Hinkle, ok, my point is why couldn't Major Casey present the pistol and the shotgun resolutions at the same time and do it in one motion. Commission Chairman Edwards stated we could probably also do them all at once, in one, unless someone did not want the shotgun. Commissioner Hinkle stated I kind of like the idea of them being recognized individually and the amount of time that they have served, I like to hear that, but why do the pistol and the shotgun both separate is my point, future consideration.

Commission Chairman Edwards stated I apologize, I was remiss, I would like to introduce Commissioner Mike Akin, our newest commissioner from Monticello. I have known Mike for many years, and he is going to be a great addition.

#### PROMOTION CERTIFICATE:

Colonel Mike Hagar presented a promotion certificate to Lieutenant Marcus Daniels promoting him to Lieutenant in the Director's Office, Office of Professional Standards.

Commission Chairman Edwards asked if everyone had a chance to look at the financial report that Jenna had sent out, any comments. Commission Chairman Edwards asked Jenna if she wanted to give us a review, is she here? John Smith stated she is, but I told her I will give the report today.

#### Fiscal Section - John Smith

John Smith stated we did provide the same financial reports that we have done in the past, but we have also created a new summary report, that is just a one page, that shows you our major appropriations or main ones at the top and our funding is the second block down. Mr. Smith stated we put some notes at the bottom that just shows currently what is going on with the agency, the big items that have a financial impact. I know we have talked about changing this report up and I wanted to know is this something, is this what you had in mind or is there something else you would like on this. Commissioner Hinkle stated I personally think it is a good start, thank you for that, but give us a little time to get used to it, we may have some questions about what items are in each category, but still yeah, I think it is a great start. Thank you for that. Mr. Smith stated any input, any change you want made if you will just let me know.

Commission Chairman Edwards asked for any comments and stated or does everybody want to digest it for a little bit. Commissioner Reeves stated we probably need to digest it, but one thing that would be helpful to me is if we had like a line graph with the monthly budget figure and with the monthly actual, so we could see how our receipts are tracking along with the budget and our expenses. Mr. Smith stated we can do that, I don't think I can get it on one page where we could see it without a magnifying glass, but we can do that for each program.

Commission Chairman Edwards asked if there was anything in particular that Mr. Smith wanted to report to the commission. Mr. Smith stated we are currently in our legislative session, we are working hard with DFA and the Governor's Office trying to get new things, new requests added to our budget and so far, communications are great. Mr. Smith stated it looks like we are going to get a lot of what we asked for and what we need. Mr. Smith stated we don't have specifics yet, we have not been, they don't have it in our appropriation bill yet, but I am hopeful next month I will have something different to tell you.

#### <u>Administrative Services</u> – Captain Roby Rhoads

Captain Rhoads presented an oral summary of the written report distributed to the Commission. He began by reporting the Human Resources/Personnel transactions for the month, we had one new hire and one termination of a probationary employee. The commissioned transactions include two new hires with the reinstatements, six promotions, two terminations, two retirements, one voluntary resignation, and nine transfers. Currently we have two military deployments.

Captain Rhoads stated this past Sunday we started Troop School with 49 recruits and when I walked in here, we had 34 left. They are in the classroom today; they are doing Crimes Against Children and Crime Lab training.

Commissioner Teague stated you said 34 today. Captain Rhoads stated 49 started and we are down to 34.

Regarding the ASP Health Plan, January paid claims were \$871,486.00 which was a decrease of \$402,843.00 from last month and the fund balance is \$413,250.00 higher than last month for a total fund balance of \$12,332,183.00. The average discount savings for the month of December was 64.5%.

Commissioner Hinkle stated Captain that 49 to 34 kind of sounds like the air pressure on my tire, I wonder if we are going to get to a flat position here. What stage do we normally get to where the numbers become pretty constant, have you, is that a decent question to ask. Captain Rhoads stated yes sir, normally the first couple of weeks is when we are going to lose the most people. If everybody comes back on Sunday that we have now, we probably will be in

pretty good shape, we will usually lose one or two somewhere along the lines for some reason. But the first week is always the roughest and that separates the people who like the idea of being a trooper and who want to be a trooper. Commissioner Hinkle stated thank you.

Commission Chairman Edwards stated we have a little bit different deal here that is not on our agenda, but Colonel Hagar has informed me that all of the command staff are going to give reports from their different divisions.

Major Mike Moyer, Regulatory and Building Operations Division, stated on the concealed handgun side currently for the month of January, the total number of valid licenses is 196,874, new applications that we received this month is 929 that was online and 80 applications that we received in the mail. Currently we are working on a new licensing system for the Used Motor Vehicle Division, PI Licensing, and also the Fire Marshal Office. We are expected to launch two of those sections online coming up in March to April after we do testing.

Major Ron Casey stated the Highway Patrol Division worked 445 crashes during the 4 days of the ice storm, we had 4 trooper cars that were damaged during that, which is pretty good compared to what we usually go through. No troopers were hurt, so we did fairly well, we had no significant SWAT calls or anything that I need to bring to your attention. Fairly uneventful other than the ice storm.

Major Stacie Rhoads stated in CID for the month of January, we worked 137 cases, 2 of those were officer involved shootings, and we worked 1 in custody death. Most notably of the cases we worked, I want to highlight 2 that I think are significant. One was some escapees that we investigated for Columbia County. Four inmates overtook the jail, overtook two jailers, escaped, stole their vehicles and were on the run. In less than 24 hours working collectively with the US Marshals, the Columbia County Sheriff's Office, Magnolia PD and other agencies we were able to get them in custody within 24 hours. So that was some very excellent work from our CID Company C.

Major Rhoads stated the other one I want to tell you about is a case that we opened January 8, 2023, it was a homicide case in Lake Village, we were called by the Lake Village PD to respond. It was an 18-year-old kid from Dermott who was there just to visit his girlfriend. There were some folks down there in Lake Village who did not like the fact that someone from Dermott was in their town, so they just drove up and shot him five times and killed him. Our agents worked really hard over the last month and just yesterday made 4 arrests in that investigation, so kudos to them. I will tell you that working in the Delta and down in that area is very difficult because witnesses are not always cooperative, they overcame a whole lot of obstacles to be able to make that arrest. So, I just wanted to highlight two of those very impressive cases that our agents were working.

Major Jeffrey Drew stated that Crimes Against Children received 6,112 calls in the Hotline, which is 1,500 more than this time last year, 2,697 of those were investigated, 538 were investigated here in CACD, out of that 538 we had a substantiation rate of 32%, which is the ones that we find true that have some credibility that we believe. We had 8 death assessments during the month. What the death assessments are, each juvenile that passes in the State of Arkansas, our hands will touch it to see what took place because we just could not believe the kid would just die for no reason and that is our way of monitoring that.

Commissioner Chairman Edwards stated even in a car accident if minors are involved don't you have to investigate it. Major Drew stated yes sir. Commissioner Basore asked how many of those are kicked up to a criminal investigation? Major Drew stated I don't have that number, but I can get it. Major Drew stated most of the investigations that we do, for 2022 over 70% of the investigations that we had was sexually oriented and most of those are worked jointly with law enforcement.

### **NEW BUSINESS:**

Commission Chairman Edwards do we have any personnel matters that we need to discuss? Colonel Mike Hagar stated yes sir, I move that we move to Executive Session to do that.

## EXECUTIVE SESSION:

Commissioner Reeves made a motion to go into Executive Session to consider promotion or lateral transfer for Captain in Highway Patrol, Troop A, Captain in Highway Patrol, Troop

K, Lieutenant in Executive Protection, Sergeant in Highway Patrol, Troop A, and Sergeant in Criminal Investigation, ICAC and to consider two requests for reinstatement.

Commissioner Basore seconded, and the motion passed. The Commission went into Executive Session at 9:27 a.m.

Commission Chairman Edwards called the meeting back to order at 10:30 a.m. and stated I think we have some personnel matters to address, Colonel Hagar do you have some recommendations.

Colonel Hagar stated yes sir, Mr. Chairman, we have two considerations for reinstatement for trooper positions. The first I would recommend reinstating Brock Neathery to Highway Patrol in Troop G. Commissioner Basore made a motion to approve reinstatement of Brock Neathery. Commissioner Reeves seconded the motion. Commission Chairman Edwards stated we have a motion and second, all in favor, any opposed. Commission Chairman Edwards stated Mr. Neathery is approved for reinstatement.

The second will be for reinstatement of Ryan Gault who would be assigned to Highway Patrol in Troop J. Commissioner Reeves made a motion to approve reinstatement of Ryan Gault. Commissioner Teague seconded the motion. Commission Chairman Edwards stated we have a motion and second, all in favor, any opposed. Commission Chairman Edwards stated Mr. Gault is approved for reinstatement.

For consideration for promotion, the first one is the Captain in the Highway Patrol Division, Troop A, I would recommend Lieutenant Jeff Sheeler. Commissioner Reeves made a motion that Lieutenant Jeff Sheeler be promoted to Captain in the Highway Patrol Division, Troop A. Commissioner Basore seconded the motion and the motion passed.

The next one is for the Captain in the Highway Patrol Division, Troop K, I would recommend Lieutenant Scott Joe. Commissioner Teague made a motion that Lieutenant Scott Joe be promoted to Captain in the Highway Patrol Division, Troop K. Commissioner Hinkle seconded the motion and the motion passed.

The next one is for the Lieutenant in the Director's Office, Executive Protection, I would recommend Sergeant Jeremy Roberts. Commissioner Hinkle made a motion that Sergeant Jeremy Roberts be promoted to Lieutenant in the Director's Office, Executive Protection. Commissioner Teague seconded the motion and the motion passed.

The next one is for the Sergeant in the Highway Patrol Division, Troop A, I would recommend Corporal Stephen Briggs. Commissioner Basore made a motion that Corporal Stephen Briggs be promoted to Sergeant in the Highway Patrol Division, Troop A. Commissioner Teague seconded the motion and the motion passed.

The next one is for the Sergeant in the Criminal Investigation Division, Internet Crimes Against Children (ICAC), I would recommend Corporal Corwin Battle. Commissioner Teague made a motion that Corporal Corwin Battle be promoted to Sergeant in the Criminal Investigation Division, ICAC. Commissioner Hinkle seconded the motion and the motion passed.

Colonel Hagar stated and lastly, we have an opening in Troop I, Highway Patrol Lieutenant and I would recommend Charles Hubbard for that Lieutenants position in Troop I, Highway Patrol. Commissioner Reeves made a motion that Charles Hubbard be demoted to Lieutenant in the Highway Patrol Division, Troop I. Commissioner Hinkle seconded the motion and the motion passed.

## NEXT MEETING:

Commission Chairman Edwards stated we have an appeal hearing for TFC Alan Aiken on March 9 scheduled and for Kurt Ziegenhorn on April 13.

Commission Chairman Edwards stated the next regularly scheduled meeting will be held on Thursday, March 9, 2023 at 9:00 a.m. with the appeal hearing for TFC Alan Aiken to be held upon adjournment of the regular commission meeting or at approximately 10:00 a.m.

Commissioner Reeves ask if we have any idea how long the hearing is scheduled? Hugh, do you have any idea how long the March hearing will take. Hugh stated that one will take a while, that will be a long hearing. Commissioner Reeves stated I may have a hard time getting here by 9:00 a.m. as I have an appointment before that here in Little Rock. Commissioner Hinkle said how about 10:00 a.m. Commission Chairman Edwards stated have the commission meeting at 10:00 a.m. followed by the appeal hearing. Commissioner Reeves asked Hugh if we would be able to finish it in half a day. Hugh stated yes sir, we should be able to finish it in half a day.

Commissioner Teague stated he is not going to be able to be here for the commission meeting that day.

Commissioner Reeves stated he should be able to be here by 10:00 a.m., he is just not sure if he could make it at 9:00 a.m.
