Karen Burgess:

- Configured 274 workstations (52 messenger workstations, 222 Mobile data terminals)
- 26 workstation removals, 13 applications for direct access
- Processed 11 ORI requests; 9 were assigned, 1 reactivated, 1 pending.
- Processed 2,546 hot files and 459 owner/lien holder requests in the last 3 months.
- Completed 64 audit reports, 3 re-audits
- 226 offline searches (emails) 300 total
- 1,013 tokens issued in the last 3 months
- 520 active missing persons in Arkansas on the website
- 188 missing females 310 missing males for a total 498 missing persons on the NCIC report.
- 100 unidentified persons as of August 1, 2023

Rick Stallings:

- Statistics for the period of March, April, and portions of May
- Certified 1,484 users during the quarter with CJIS Online Security Training with a 99.7% pass rate.
- Certified 16,465 vendors across the nation with a 99.8% pass rate.
- Basic training: 585 users with an 88.9% pass rate.
- 843 users took the Basic Refresher, with an 86.6% pass rate.
- Advanced training (New Testing Methods):
 - Day 1- 94 users tested with a 100.0% pass rate
 - Day 2- 96 users tested with a 99.0% pass rate, 1 Failed Day 2
 - Day 3- 94 users tested with a 100% pass rate

- 195 advanced users recertified with an 86.7% pass rate.
- Creating an Online Basic Training for users
- VINE had 137,314 new registrations.
- Delivered 484,252 VINE Notifications
 - 65,923 by phone
 - 246,123 by text
 - 155,163 by email
- JusticeXchange had 167,008 law enforcement searches.
- Investigators placed 28,495 watches; this yielded 5,614 hits on those watches.
- 12,121 DL photos viewed.
- AlertXpress utilized 106 times during this quarter
- Pseudoephedrine purchases 31,021.
- NPLeX blocked 1,675 attempts to buy pseudoephedrine (4,598 grams).
- Placed 99 watches with 0 hits
- Metal Theft tracking Program reported 98,280 tickets of 223,514 items scrapped.
- 5,195 of those tickets yielded a hit on reported stolen items.

Ralph Ward:

- Current NIBRS program status: there are 308 agencies cleared to request & report.
- 14 agencies and vendors are testing to certify their RMS.
- Working with RMS and software vendors with assisting law enforcement agencies with technical reporting issues.
- 2022 Crime Statistics, uploaded on ACIC website
- Victims of Crimes Reports, gives victims a voice. They're used for funding and research by universities, hospitals, domestic violence and victim advocates
- Collecting additional charge codes from Administrative Office of the Courts

Contiki Cooper: Sex Offender Registry

- Sex offender Stats: 18,817 registered sex offenders on the registry. Registering about 100 new registrants each month
 - Compliant sex offenders: 8,872
 - Delinquent sex offenders: 1,450
 - Incarcerated sex offenders: 3,641
 - Out of state sex offenders: 4,317
 - Address Unknown sex offenders: 161
 - Deported sex offenders: 207
 - Incapacitated: 116
 - Out of USA- 50
